





6mm azul reflexivo vidro temperado é revestido um ou mais filme metálico na superfície do vidro, 6mm azul reflexivo de vidro temperado pode reduzir o acúmulo de calor interno, a mesma coisa, porque pode apresentar rico e colorido refletir o tom no vidro, ele pode fazer o exterior do edifício floweriness e poly cromo.

O tipo de vidro refletivo revestido

O vidro reflexivo on-line também é chamado de Vidro Refletivo de Revestimento Duro. O revestimento é realizado quando a superfície do vidro flutuante ainda está quente. O revestimento seria mais firme que o revestimento no vidro refletivo off-line.

O vidro reflexivo off-line também é chamado de vidro reflexivo de revestimento suave. O processo de revestimento é realizado após a produção de vidro azul colorido de 6 mm. O vidro reflexivo off-line é mais fácil de ser oxidado do que o vidro revestido on-line. Assim, o seu revestimento é sempre usado como camada interna de vidro laminado, vidro isolado, como o vidro isolado reflexivo low-e .

As características do vidro temperado reflexivo azul de 6mm

- 1) a força, vidro moderado reflexivo é quatro a cinco vezes mais forte do que o vidro reflexivo padrão e não quebra em estilhaços afiados quando falhar.
- 2) Taxa de transmissão de luz visível elevada, baixa taxa de reflexão, baixa taxa de radiação (e & It; 0,1).
- 3) Evite a poluição luminosa e construa um bom ambiente ecológico.
- 4) pode ser cortado, dobrado, temperado, reforçado pelo calor e laminado sem afetar o revestimento.
